The Barnes ANGB RAB Meeting No. 3 was held on April 27, 2023 at 1800, via WebEx. The following notes provide a summary of discussions during and after the presentation and are not intended to serve as a transcript or further explain information provided during the meeting. A copy of the presentation is attached in **Attachment B**.

- The meeting began at 6:00 p.m. with the RAB facilitator, Amy Brand/Jacobs, welcoming participants. Amy presented the agenda, provided an overview of how to use the WebEx meeting platform, and then invited the Base Co-chair and Community Co-chairs to provide opening remarks.
- 2 Col Halasikun, Base Co-Chair and representative of Barnes ANGB, and Community Co-Chair Kathleen Hillman made opening remarks welcoming and thanking RAB members and community participants.
- The RAB agreed that meeting summaries will be reviewed via email and posted on the 104FW website after approval.
- 4 RAB co-chair Eric Oulette is no longer with the Chamber of Commerce. Amy indicated this does not disqualify him from participating as the RAB co-chair. She will follow up with Eric to determine if he plans to remain in the position or is choosing to step down.
- Kathleen Hillman asked if RAB members could be added. Amy will review the RAB charter/operating procedures to determine how and when RAB members can be added. There is a RAB application that needs to be completed and it outlines expectations for the role.
- 6 Kristen Mello asked if we publicize for the RAB position and can we publish the application in different languages and advertise in other languages.



Meeting Minutes

Meeting #3 - Barnes Air National Guard Base (ANGB) Restoration Advisory Board (RAB) April 27, 2023, 6:00 p.m.

- The group reviewed future meeting dates and discussed whether the January 25 2024 date should be shifted to early February to account for the December holidays. RAB agreed to keep the January 25th date.
- The group discussed hybrid versus virtual meetings. The consensus was to conduct future meetings as a hybrid of virtual and in-person.
- The group discussed setting up a site tour on the same day as the next RAB meeting. Kristen asked if it could be open to community members whose primary language is not English. Amy asked Kristen if she thought the Spanish speaking community would be interested in a site tour. Kristen indicated that the Spanish speaking community understands enough of the site activities that they buy bottled water.
- 10 Col Halasi-kun will need a head count for the tour to coordinate with security.
- Maj Sinclair said the Air Force was reviewing the proposal for the TAPP grant and asked if the RAB agreed with the change in professors that would be involved in the review. The RAB supported the professor that was proposed and asked if he could join the tour. Contracting will check if he is agreeable to attending the tour.
- 12 Amy will check with the National Guard Bureau (NGB) on posting the recorded meeting on You Tube.
- 13 Chris Brown indicated that the contract for the Barnes ANGB Per- and Polyfluorinated Substances (PFAS) Remedial Investigation (RI) should be awarded by the end of FY23 (September 30, 2023).
- 14 Kristen indicated that the RAB would like to align the next Technical Assistance for Public Participation (TAPP) grant to help review the PFAS RI Uniform Federal Policy Quality Assurance Program Plan (UFP-QAPP).
- 15 Chris Clarke asked if technologies exist that can remediate PFAS at great depths. Chris Brown indicated that existing technologies are reviewed during the Feasibility Study step in the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) process.
- 16 Kristen asked if there are opportunities for the RAB to research remediation technologies.
- One source for research developing technologies is through the Department of Defense (DOD) Strategic Environmental Research and Development Program (SERDP) and the Environmental Security Technology Certification Program (ESTCP) (https://serdpestcp.org/). The DOD funds research through these programs to meet their environmental and installation energy and water challenges.
- The RAB welcomed Chris Brown, the new NGB Project Manager, to the challenges that Barnes ANGB is facing.





- Scope: To review Preliminary Assessment, Site Inspection, Expanded Site
 Inspection, and MADEP Residential Drinking Water Well Sampling and Point of
 Entry Treatment Systems (POETS) and provide independent interpretation and
 summary of the conclusions, including but not limited to extracting and
 explaining what has been found out about the plume(s), characteristics,
 size/fate/transport/migration/profile/etc.

Environmental Restoration Program



- Environmental investigations/cleanup (Non-PFAS sites) has been ongoing at Barnes since 1987
 - Six sites were cleaned up/closed by 2015
 - ERP Site 2 undergoing long-term monitoring (coordinating with City of Westfield)
 - Two munitions response sites closed in 2012
 - Two additional Former Underground Storage Tank (FUST) sites investigated and closed
- Investigation of PFAS began in 2016
- Coordination with regulatory agencies and stakeholders
 - Massachusetts Department of Environmental Protection (MassDEP)
 - National Guard Bureau





Site 2 Status Update



- Site 2, Former Underground Storage Tank Area
 - 4 jet fuel tanks were removed in 1998
 - Biosparging system operated from 2005-2009
 - Soil excavated in 2009
 - In-situ chemical oxidation, 6 injections 2009-2016
 - Additional investigation was completed in 2018
 - Release Abatement Measure (RAM) Completion Report 2019
 - Concluded that LNAPL had been defined and remediated to the extent feasible
- Long-term monitoring events in 2021 & 2022
 - Confirm conclusions from the RAM Completion Report
 - Contaminant is not moving but degrading in place
- Working toward a Permanent Solution Statement
 - Coordinating with City of Westfield and the Airport
 - Recommendation is an Area Use Limitation






CERCLA Process



Comprehensive Environmental Response, Compensation, and Liability Act



A removal action may be initiated at any time during the process if human health or the environment is in immediate danger.



Action and Screening Values for PFAS



- U.S. Environmental Protection Agency (EPA) Draft Maximum Contaminant Level (MCL)
 - PFOS 4 parts per trillion (ppt), PFOA 4 parts per trillion (ppt)
- EPA Lifetime Health Advisories (LHA) of 70 (ppt) for PFOS and/or PFOA in drinking water
- OSD screening limits (6 July 2022) include screening limits for three additional analytes (PFHxS, PFNA, and HFPO-DA), all were compared against site data:

Chemical	RSL TAP Water (ng/l or ppt)	Residential: RSL Soil (mg/kg or ppm)	Industrial: RSL Soil (mg/kg or ppm)
PFOS	4	0.013	0.16
PFOA	6	0.019	0.25
PFBS	601	1.9	25.0
PFNA	6	0.019	0.25
PFHxS	39	0.13	1.6
HFPA-DO	6	0.023	0.35


 All environmental samples (soil, groundwater, surface water, and sediment) will be submitted to the analytical laboratory for PFAS by Method 1633 (40 analytes) in the RI



CERCLA Process



Comprehensive Environmental Response, Compensation, and Liability Act



A removal action may be initiated at any time during the process if human health or the environment is in immediate danger.



Next Steps



- Next step is the Remedial Investigation (RI)
 - RI will determine nature and extent of PFOS/PFOA migration
- Funding status of Remedial Investigation
 - On AFCEC fiscal year (FY) 2023 spend plan
 - Funds Assurance Letter Received
 - ANG coordinated with New England United States Army Corps of Engineers (USACE) to develop schedule/budget for contracting in FY 2023
 - Projecting to award RI end of FY 2023
- 104 FW will continue to collaborate with the MassDEP and the City of Westfield
