- Serve a specific term and attend RAB meetings regularly (2 to 4 times per year) as required by the RAB Charter (to be adopted by the initial RAB members).
- Review and comment on documents and activities associated with the Barnes ERP. A technical background is not required.
- Be willing and available to act as a liaison with the community to facilitate two-way exchange of information between the community and the RAB regarding the Barnes ERP.
- Participate productively in RAB discussions.
